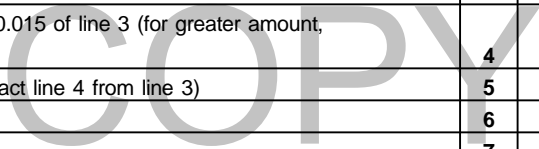

WITHIN TEN (10) BUSINESS DAYS OF RECEIPT OF NOTICE OF A SUSPECTED CONFLICT OF INTEREST, THE CHAIRPERSON OF THE BOARD OF GOVERNORS SHALL INFORM THE EXECUTIVE COMMITTEE OF THE BOARD THAT A POTENTIAL CONFLICT OF INTEREST MAY EXIST. THE CHAIRPERSON SHALL THEN UNDERTAKE A TIMELY AND APPROPRIATE INVESTIGATION, GIVE HIS OR HER WRITTEN OPINION CONCERNING THE EXISTENCE OF A CONFLICT, AND MAKE WRITTEN RECOMMENDATIONS FOR APPROPRIATE ACTION TO THE ENTIRE EXECUTIVE COMMITTEE. PERSON SHALL NOT BE PRESENT DURING THE DISCUSSION OR DECISION ON THE MATTER. THE BOARD SHALL BE RESPONSIBLE FOR THE ULTIMATE DISPOSITION OF POTENTIAL CONFLICT OF INTEREST. 5. A COPY OF THIS CONFLICT OF INTEREST STATEMENT SHALL BE FURNISHED TO EACH BOARD AND STAFF MEMBER WHO IS CURRENTLY SERVING ISC OR WHO MAY HEREAFTER BECOME ASSOCIATED WITH IT. EACH CURRENT BOARD AND STAFF MEMBER SHALL SIGN THE ATTACHED ACKNOWLEDGMENT AND DELIVER THE SIGNED ORIGINAL TO THE PRESIDENT, WHO SHALL MAINTAIN A FILE OF ALL SUCH ORIGINALS. EACH NEW BOARD OR STAFF MEMBER SHALL SIGN THE ACKNOWLEDGMENT AND DELIVER IT TO THE PRESIDENT AT THE TIME OF ELECTION OR HIRING, AS APPLICABLE. THIS POLICY AND ITS APPLICATION SHALL BE REVIEWED ANNUALLY FOR THE INFORMATION AND GUIDANCE OF BOARD AND STAFF MEMBERS.

6. THE FAILURE OF ANY EMPLOYEE TO STRICTLY COMPLY WITH THE TERMS OF THIS CONFLICT OF INTEREST POLICY SHALL BE DEEMED GROUNDS FOR PROBATION, SUSPENSION, OR DISMISSAL. ANY BOARD MEMBER FAILING TO COMPLY WITH THIS POLICY WILL BE ASKED TO RESIGN FROM THE BOARD OF GOVERNORS.
